Introduction

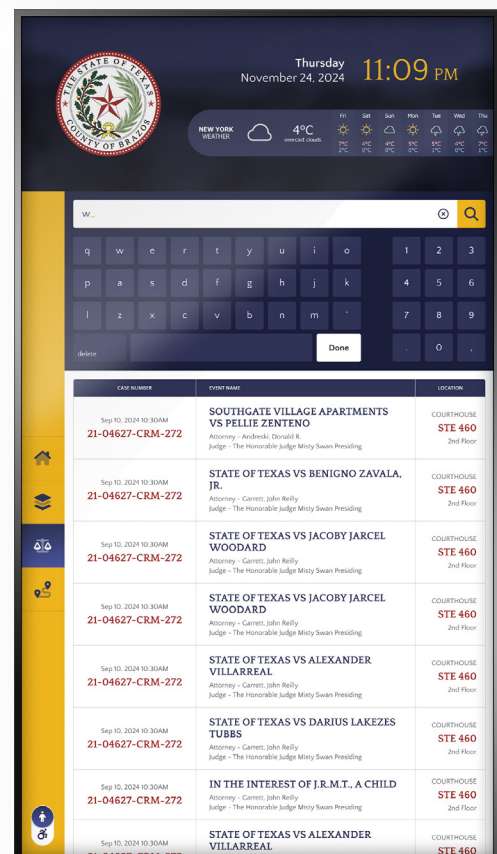
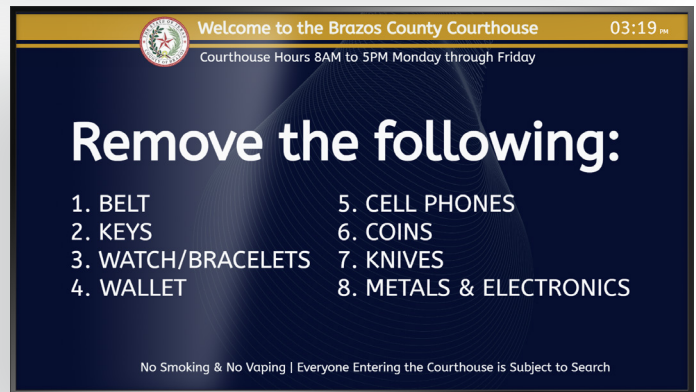
Brazos County Courts, located in southeastern Texas, form the central hub for judicial proceedings in the region. The court system is structured into multiple divisions, including District Courts, County Courts at Law, and Associate Courts, each addressing specific legal matters to uphold justice and community service.

The District Courts, consisting of the 85th, 272nd, 361st, and 472nd courts, are the primary trial courts handling felony criminal cases, civil disputes exceeding \$500, and family law issues. These courts also manage appellate jurisdiction over County Commissioners Court matters, ensuring oversight and legal accountability.

The County Courts at Law, established as CCL-1 and CCL-2, handle a broad spectrum of cases, including misdemeanor criminal offenses, family matters, probate cases, and civil cases up to \$250,000. They also oversee appeals from justice of the peace and municipal courts, maintaining a comprehensive approach to local justice.

The Associate Courts play a supportive role, managing specific criminal and family cases to alleviate the caseload of higher courts. Additionally, the Justices of the Peace handle minor civil disputes and traffic violations, ensuring accessible and efficient legal resolution for residents.

With a commitment to maintaining transparency and efficient legal proceedings, Brazos County Courts continue to adapt to modern challenges while preserving the community's trust and legal standards.



The Challenge

Brazos County Courts faced several challenges with their existing communication and wayfinding systems. The traditional setup included paper notices and outdated monitors, which made it difficult to update information efficiently. Changes in courtroom locations or scheduling required manual updates, leading to confusion among visitors.

Finding specific courtrooms and departments within the courthouse was often a time-consuming task for the public. There was no centralized system to display updated dockets or guide visitors effectively through the multi-floor building. This lack of wayfinding support often resulted in individuals wandering the halls, unsure of where to go.

In partnership with Avinext, the county aimed to find a digital signage solution that would enhance public communication and streamline the posting of legally required information. The goal was to implement a modern, interactive system that could provide real-time updates while being easy for staff to manage.

The project required an interactive solution that could automatically pull docket data from the county's existing systems. Integrating with the Tyler Technologies Odyssey platform was critical to ensuring accurate and current court information. Additionally, the signage needed to serve multiple functions, from welcoming visitors to guiding them to their destination.

By selecting Mvix as their digital signage provider, Brazos County Courts aimed to modernize their operations and provide a more professional, user-friendly experience for both staff and the public.



Deployment & Usage

Mvix implemented a robust digital signage network tailored to the needs of Brazos County Courts. The deployment included 11 Mvix Standard Players and 2 Mvix Pro Digital Signage Players, supported by custom development and script coding to ensure seamless integration with existing systems.

Informational Displays – Positioned

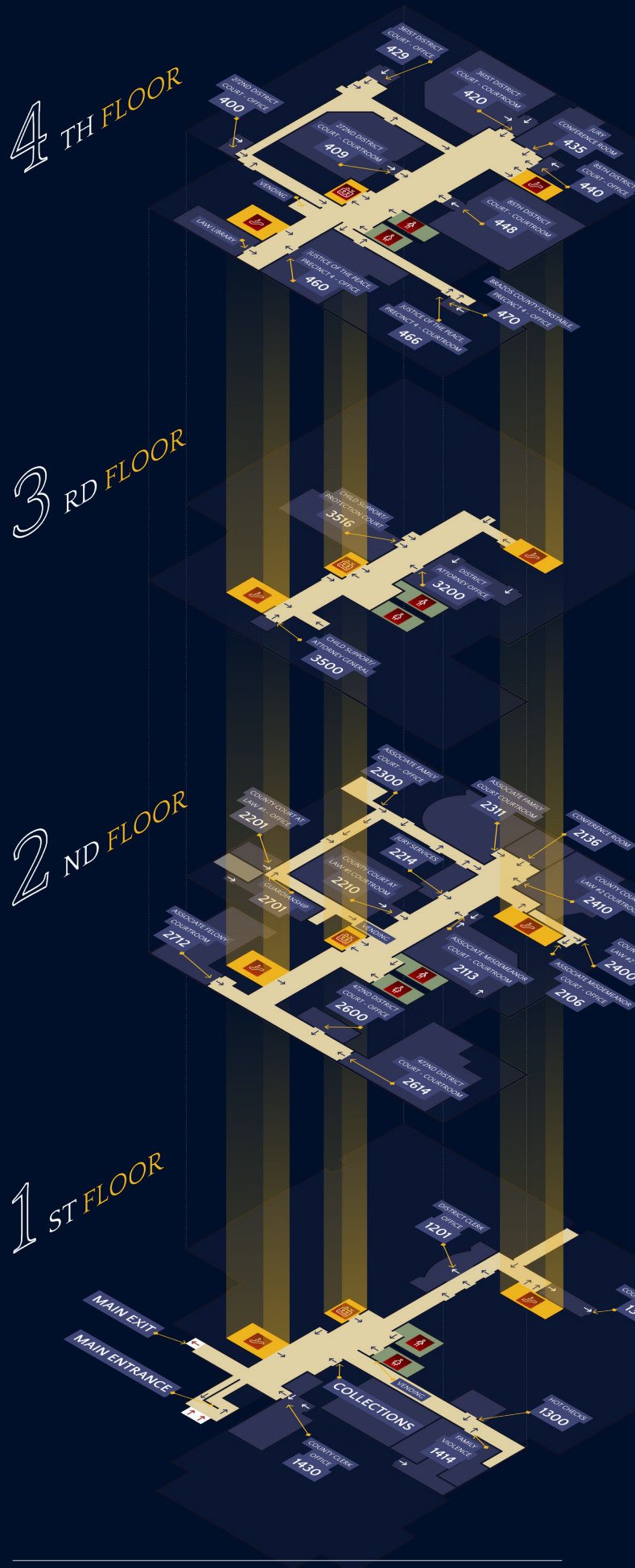
- near courtrooms to show up-to-date docket information.
